

CENTRAL ILLINOIS RADIO SOCIETY, Inc. BYLAWS

ARTICLE I: OFFICERS

The officers of Sentral Illinois Radio Society (SIRS) shall be:

- A. President
- B. Vice President / Historian
- C. Secretary
- D. Treasurer
- E. Communications Officer
- F. Safety Officer

ARTICLE II: DUTIES / TERM OF OFFICE

Section 1: President

The President shall preside at all meetings of the Club and shall act as spokesperson for the Club in all matters pertaining to it. The President shall have such other powers as may be designated from time to time by the Executive Committee.

Section 2: Vice President / Historian

The Vice President / Historian shall assist the President and will perform the duties of the President in his/her absence. In addition the Vice President shall maintain a historical record (archive) of all club functions to include pictures, articles, Newsletters.

Section 3: Secretary

The Secretary shall record the minutes of all meetings and maintain an attendance roster of such meetings. The Secretary shall assist the President in handling all correspondence pertaining to the club. The Secretary shall maintain a depository of corporate documents.

Section 4: Treasurer

Treasurer shall have the responsibility to receive and deposit funds in the account(s) of SIRS. The Treasurer shall receive approval from the President, and in the absence of the President, the Vice President, prior to the disbursement of funds from Club accounts. The Treasurer shall be responsible for maintaining an accurate accounting of all monies received and disbursed by the Club, and for making financial reports to the membership. The Treasurer shall have such other powers and duties as designated from time to time by the Executive Committee.

Section 5: Communications Officer

The Communications Officer will publish a monthly Club Newsletter and distribute internal communications to members to keep them informed of club meetings and activities. The Communications Officer will also maintain external communications with other clubs, national organizations, publications, and the general public to promote the club and its activities.

Section 6: Safety Officer

The Safety Officer will develop and post field procedures and rules.

Section 8: Term of Office

The elected officers of SIRS shall serve for one (1) year from date of installation.

Section 9: Executive Committee

The Elected Officers shall constitute the Executive Committee. The Executive Committee shall serve at the direction of the President.

ARTICLE III: ELECTIONS

Section 1: The election of officers shall take place annually during the October meeting.

Section 2: A Nominating Committee, appointed by the Executive Committee, shall prepare a slate of candidates for the various Officer positions.

Section 3: Newly elected Officers shall take office at the November meeting.

ARTICLE IV: VACANCIES

Section 1: A vacancy in any office, excluding President, shall be filled by a special election at the next regular meeting.

Section 2: In the event of a vacancy in the office of President, the Vice-President shall assume the President's office. The vacant Vice President's office shall then be filled as proscribed in Article 4, Section 1.

Section 3: The person elected to fill a vacant office shall serve until the end of the term for which his/her predecessor was elected.

ARTICLE V: WEBMASTER

Section 1: The Webmaster serves as the primary contact for all aspects of the club's website(s), handling a range of responsibilities that may include web design and development, routine content maintenance, and various updates to ensure sites align with the goals and objectives of the club. To keep the club's president updated with new URL, site name, and passwords as needed.

Section 2: The Webmaster is not an Executive position.

ARTICLE VI: MEETINGS

Section 1: Regular meetings shall be held monthly.

Section 2: Special meetings may be called at any time by the President or upon a request by the executive committee of the membership. All members shall be notified at least three (3) days in advance of any special meeting being held.

ARTICLE VII: REGULAR BUSINESS

Section 1: All regular business affairs and enterprises conducted by SIRS shall be directed by the President. In the absence of the President, the Vice President shall assume the duties of the President.

ARTICLE VIII: DUES AND FEES

Section 1: The annual membership year shall commence on April 1st and expire on March 31st of the next calendar year. The dues shall be one-hundred (100) dollars. Dues must be paid annually by April 1st of the current year.

ARTICLE IX: SPECIAL FUNDS

The Treasurer is authorized to receive contributions or specially obtained funds from any individual or institution, to be applied toward the operating expenses of the club.

ARTICLE X: MEMBERSHIP

Section 1: Each applicant must be sponsored by a current member of the club.

Section 2: A member will be considered in good standing only when dues are paid within thirty days of the date due.

Section 3: There will be five (5) categories of membership.

Regular Member:

1. Must be age sixteen (16) or older and otherwise meet qualifications set forth in these Bylaws and Article III of the Constitution.

Junior Member:

1. A person is a Junior Member until the end of the year in which they reach their sixteenth birthday and otherwise meets the qualifications set forth in these Bylaws and Article III of the Constitution.
2. Each Junior Member must be sponsored by an adult member already in good standing.
3. The dues for the Junior Member will be 1/2 the regular dues.
4. Upon reaching the age of sixteen (16) he/she will then be considered a Regular Member and at the time his/her dues are renewable must assume all of the responsibility of a Regular Member.
5. Junior Members will be allowed flying privileges at the field only when accompanied by an adult member in good standing and with the understanding that the adult assumes full responsibility of the Junior Member's actions the entire time the Junior Member is at the field.

Family Member:

1. Family Membership is available for anyone who lives in the same household as a dues paying Regular Member AND who is joining SIRS who EITHER holds an AMA Youth Membership Card (For those under 19 years of age as of July 1st, 2007) OR who is a full-time college student. Family Membership can also apply to the spouse of a Regular Member.
2. The dues for the Family Member(s) are included in the dues paid by the Regular Member.

Honorary Life Member:

1. Honorary Life membership is a special honor bestowed by the membership on a member for prolonged dedicated service to the club. Life members do not pay dues.

Paid Life Member:

1. Paid Life Members will pay no more dues after buying into this membership. This membership is a donation to support the SIRS Club in future years. Regular members who are 65 years of age or older are eligible to purchase a Paid Life Membership. The buy in price shall be \$250 plus \$100 times their additional life expectancy years using the most recent Social Security Actuarial Life Table at the time of their Paid Life Membership purchase. This is a non-refundable purchase. The monies from the purchase shall be held separately from the regular operating account in the Life Member Account. Annually on April 1st an amount equal to the current SIRS Club dues for each Paid

Life Member will be moved from the Life Member Account to the SIRS Club operating account. In the event of a SIRS Club financial emergency the Paid Life Member Account may be used with the approval of 60% of the current members.

2. Example: John Doe is 65 and buys in to a Paid Life Membership. His additional years of life expectancy = 18. So, $\$250.00 + (\$100.00 \times 18) = \$2050.00$ which would be his buy in price.

Section 4: For NEW members (not previous members) of the club who join sometime during a calendar year, the dues will be prorated for each full month (or fraction thereof) remaining in the calendar year.

Section 5: All Regular, Junior, Life and Family members must hold a current AMA Membership card.

ARTICLE XI: COMMITTEES

The President shall have the power to appoint committees whenever feasible to perform special functions of the club.

ARTICLE XII: AMENDMENTS

Section 1: Bylaws may be amended in the following way:

The proposed change will be submitted to the Communications Officer and sent to the membership. The proposed change will be discussed at the following meeting. The proposed change, in its final form, will be sent to the membership.

Section 2: In order for a proposed change to be passed, it requires a 60% majority vote of the members present at the two consecutive meetings following publication.

ARTICLE XIII: DISCIPLINE

Any member may be suspended or expelled from the club by unanimous vote of the Executive Committee for the following reasons:

- 1) For violation of the field or AMA safety rules.
- 2) For misconduct or activities that are illegal involving club members or club property.

Expelled members will not receive any refund of dues or any other compensation.

ARTICLE XIV: Disbandment of the SIRS Corporation

The SIRS Executive Committee can initiate the process of disbanding the SIRS Corporation by a unanimous vote. The SIRS Corporation can then be disbanded by a majority vote of the membership present at a special meeting held for the

express purpose of ending the existence of said corporation. The dispersal of any assets held by the SIRS Corporation shall be governed by regulations in force, at the time of disbandment, by the State of Illinois for asset dispersal of disbanded Illinois Not-For-Profit Corporations.
